2.1 BECK LANE

The Clerk reported that No Unauthorised Motor Vehicles notice had been put up on the A159 end of Beck Lane. Motorbikes are therefore not allowed on this track. However, Mr Marsh (LCC) has said that if the Motorcycle Trials event takes place, he needs photographs of the area which the trials intend to cross. The present designation of the track allows horse and carriages, horses and pedestrians. If the Council experiences problems with these activities Mr Marsh should be contacted again.

2.2 PARISH NOTICEBOARD

Still very difficult to open but it was agreed not to plane the sides as, with the onset of better weather, the board will probably shrink again.
