- 6.2 <u>REF: 0303416.3</u> An appeal was made against the council's decision to refuse the removal of a birch at Orchard Lodge, Westgate, Scotton, ref: 030341. Also against the condition requiring two replacement trees to be planted in compensation for the loss of the three trees given consent to be removed. The Planning Inspectorate has now concluded the appeal and the appeal was allowed, i.e. the birch tree in the front driveway can now be felled and the two replacements are not going to be planted.
