Provision of Street Light; Street Sign to read High Street; (possibly illuminated) Double White Lines; Slight Road Widening; Trees and hedges cut back. It was agreed that the Clerk should contact Forestry Commission to ask if they could trim all their trees/hedges on the roadsides; contact Streetlighting to ascertain whether a street light would be viable and the estimated cost; contact Police to ask if the 'Smiley Face' could be put on a road such as this as a temporary measure.
