PLOT SIZE AND STREETSCENE

This Council are concerned that the building may be over dominant for the size of the plot. This could have an adverse effect on the streetscene.

Building Line

This council request that WLDC check that the proposed development is within the building line.

DRAINAGE

Concerns have still been raised with regard to the effect the building will have on the present drainage provision.

NOISE AND DISTURBANCE

Residents have raised concern regarding the noise and disturbance which will occur from this proposal as the road is narrow but well used.

6.3 PLANNING APPLICATION 134742 – LOWFIELD FARM, MIDDLE STREET COMMENTS TO BE RETURNED

then this council would be very much against this application.

This Council found the drawings extremely hard to understand. There is a very large well established Sycamore Tree and the Council are concerned that this will be destroyed. It is also difficult to ascertain where the building will sit as there is a high wall at the side of the property, then a drop into the lane where there is a smaller wall. If the extension were to go right to the small wall at the side of the lane known as Middle Street the impact on this pleasant leafy lane would be detrimental to the pleasure of the many people who regularly walk this area. It would be very imposing and cause problems for other residents who live along this small lane with regard to vehicle access and egress to their drives. If the proposal is that the wall be built at the bottom of the drop, although we would contend that the actual boundary of the property is on the top of the bank,

This Council are requesting more clarification with regard to the actual boundaries of the proposal.
